


HALE'S SUBDIVISION

OF THE SOUTH HALF OF BLOCK FOUR (4) OF FOUTS FIRST ADDITION TO McPHERSON KANS.



Hale's Subdivision of the south half of Block Four (4) of Fouts First Addition to the city of McPherson Kansas is located on the south half of Block Four (4) of Fouts First Addition to the city of McPherson Kansas, and a strip of land Twenty five (25) feet wide off the west end of lots 9-10-11-12-13-14 & 15 of Block Five (5) Freeman's Addition to the city of McPherson, Kansas, and is divided into blocks, lots & streets as shown by this plat. All lots are Forty five and nine tenths (45.9) feet wide and one hundred thirty one and eighty five hundredths (131.85) feet long.

I hereby certify that the foregoing plat and notes of Hale's Subdivision of the south half of Block Four (4) of Fouts First Addition, conforms strictly to the survey made by me on the 17th day of February, A.D. 1887.

Hale (his wife) being the owners of the following described property situated in McPherson County, State of Kansas, to wit: The south half of Block Four (4) of Fouts First Addition to the city of McPherson, Kansas, and a strip of land Twenty five (25) feet wide off the west end of lots 9-10-11-12-13-14 & 15 of Block Five (5) Freeman's Addition to the city of McPherson, Kansas (which said parts of lots are set aside as streets) have caused to be made out an accurate plat of said premises, and subdivision, to be known and designated as Hale's Subdivision, which said plat with the statement and certificate of A.
