DESCRIPTION

Beginning at a point 280 feet East of the Northwest corner of said SEI/4, NWI/4, and also being the Northeast corner of Block I of said sub-division, thence South along the East line of said Block I 180 feet, thence East 42 feet, thence South 302.3 feet, thence Southeasterly 17.12 feet, thence Southwesterly 120 feet, thence West 80.08 feet, thence South 190 feet to the Northwest corner of Lot I Block 3 of Quivira Acres First Addition, thence East along the Northerly line of said Quivira Acres 30 feet, thence Southeasterly 366.4 feet along said line, thence East 338 feet, thence Northeasterly 97 feet, thence Northeasterly 192 feet, thence East 60 feet to the Northeast corner of Lot 18 of Block 3 of Quivira Acres, thence North 160 feet to the Southeast corner of Lot 9 Block 2, Homestead Acres sub-division, thence West 142 feet, thence North 595.75 feet along the West line of said Block 2, thence West 33 feet, thence North 120 feet to the North line of said SE1/4, NW1/4, and also being 355 feet West of the Northeast corner of said SEI/4, NWI/4, thence West 693.8 feet to the point of beginning. The land herein described contains 16.7 acres more or less.

EASEMENTS

All easements are for the installation of utilities and to provide water drainage ways within the area to the streets.

SIDEWALKS

A four foot wide concrete sidewalk is to be constructed one foot from the property line toward the street on the front side of Lots 13 through 21, Block 3, Lots 15 through 30, Block 4.
