Situated on a portion of the SE 1/4 of Section 23 T19S R3W of the 6th P.M., McPherson County Kansas

SURVEYOR'S CERTIFICATE

I, the undersigned, licensed land surveyor of the State of Kansas, do hereby certify that the following described tract of land was surveyed on October 10, 1997, and the accompanying final plat prepared and that all the monuments shown herein actually exist and their positions are correctly shown to the best of my knowledge and belief.

The Southeast Quarter (SE/4) of Section Twenty—three (23), Township Nineteen (19) South, Range Three (3) West of the 6th P.M. lying South of the Central Kansas Railroad Right—of—Way, except railroad rights—of—way, McPherson County, Kansas.

Said Tract contains 107.2 Acres more or less and is subject to any easements or right—of—way of record. Bearings are Assumed.

Railroad right—of—way lying south of the centerline of the Central Kansas railroad in the Southeast Quarter of Section 23—19—3 equals 18 acres more or less.

GENERAL NOTES:

Owners of lands within this subdivision do hereby bind themselves to waive any protest to annexation by the City of McPherson, Kansas.

See Drainage Report by Camp Dresser and McKee dated January 1998.

A five foot wide sidewalk shall be constructed one foot from the property line in street right—of—way along the full length of Limestone Road and 17th Avenue. These sidewalks are to be constructed at such time that the City of McPherson annexes this property and extends the sidewalk system to meet this property, and as future subdivision occurs.

Any future non—agricultural development of any or all of Lot B shall be required to produce a storm water drainage plan that would conform to the City of McPherson Storm Water Management Policy prior to the receipt of a zoning or building permit.

Lots B1 and B2 are tied together and are not to be sold separately until such a time that access is made available to Lot B2 from a public thoroughfare.

Access to this parcel of land will be limited to one collector road from 17th Avenue and one collector from Limestone Road. The 17th Avenue access road to the McPherson Area Solid Waste Utility (MASWU) shall be relocated upon future development of Parcel B to conform to this limited access requirement. Said access to be approximately 1/4 mile (1320 feet) ± 300 feet from the intersection of 17th Avenue and Limestone Road.


