
## FINAL PLAT

## LAND SURVEYOR'S CERTIFICATE AND DESCRIPTION

I, the undersigned licensed land surveyor of the State of Kansas, do hereby certify that the following described tract of land was surveyed on February 8, 2016 and the accompanying final plat prepared and that all monuments shown herein actually exist and their positions are correctly shown to the best of my knowledge and belief:

A portion of the Northwest Quarter of Section 21, Township 19 South, Range 3 West of the 6th Principal Meridian, City of McPherson, McPherson County, Kansas described as follows:

Commencing at the Northwest corner of said Northwest Quarter; thence on a NAD 83 Kansas South Zone bearing of North 88°45'53" East on the North line of said Northwest Quarter a distance of 468.47 feet (468.57 Record) to the Northeast corner of First Lamco Addition to the City of McPherson, Kansas, also being the point of beginning; thence continuing North 88°45'53" East on said North line a distance of 214.48 feet (214.53 Record) to the Northwest corner of Trail North Subdivision, City of McPherson, Kansas; thence South 00°12'19" East along the West line of said Trail North Subdivision a distance of 585.19 feet (578.66 Record) to a 5/8" rebar in concrete; thence South 89°49'47" West a distance of 214.51 feet (214.53 Record) to a 5/8" rebar in concrete being the Southeast corner of Lot 1, Block A of said First Lamco Addition; thence North 00°11'56" West along the East line of said First Lamco Addition a distance of 581.20 feet (578.66 Record) to the point of beginning.
