

KNOW ALL MEN BY THESE PRESENTS, That H. Eddie Froese and Verna Froese, his wife owners and proprietors of land hereinafter described, have caused said land to be surveyed and platted under the name of Park Lane Second Addition to the City of Inman, Kansas and caused the same to be subdivided into block, lots, alley and street as shown on accompanying Plat

DESCRIPTION. Part of the East Half of Northwest Quarter (E $\frac{1}{4}$, NW $\frac{1}{4}$), Section Sixteen (16), Township Twenty One (21), South, Range Four (4) West, 6th P.M. Beginning 350 feet south and 658.5' East of Northwest Corner of East Half, Northwest Quarter of said Section 16, thence southwesterly 253.5 feet to a point 598.2 feet south and 605.5 feet east of said Northwest Corner thence Southwesterly 261.1 feet to a point 811.6 feet south and 451.7 feet east of said Northwest Corner, thence Southwesterly 276.7 feet to a point 196.5 feet east and 923.9 feet south of said Northwest Corner, thence south 204.6 feet to a point 196.5 feet east and 1128.5 feet south of said Northwest Corner, thence northeasterly 1091.9± feet along a curve of 776 feet radius and parallel with the east and south line of City Park to a point 856.5 feet east and 350 south of said Northwest Corner, thence west 198' feet to place of beginning.

All streets and Alleys are hereby dedicated to and for use of the public.
